## Monthly Update

Month Ending: October 31, 2018

## **Unemployment Insurance**

**Initial Claims** – 3,605 initial claims were processed during the month of October, an increase of 927 (34.6%) from the previous month, and an increase of 187 (5.5%) from a year ago. Of the 2,349 monetary determinations issued in October 102 (4.3%) were monetarily ineligible.

Weeks Claimed – 28,334 weeks claimed were processed during the month of October, an increase of 3,048 (12.1%) from the previous month and a decrease of 1,794 (-6.0%) from a year ago. There were 26,257 payments made in October, which resulted in payments totaling \$9.5 million. There were 1,752 (6.7%) partial payments issued in October 2018 compared to 1,987 (7.2%) last year. The average weekly benefit payment was \$361. The number of weekly benefit payments is averaging 15.0 weeks per claim.

**Workshare** -41 initial claims were processed for Workshare benefits this month, a decrease of 70 (-63.1%) from the previous month and a decrease of 38 (-48.1%) from October 2017. It is estimated that 12 layoffs were averted this month as a result of Rhode Island's Workshare program.

**First and Final Claims** – 1,610 first payments and 663 final payments were issued in October 2018. The current exhaustion duration ratio is 27.4 percent.

**Non-monetary Determinations** – 1,700 non-monetary determinations were issued during the month of October 2018. Of the 1,700 determinations, 1,051 (61.8%) were separation issues and 649 (38.2%) were non-separation issues. Denials were issued for 403 (38.3%) separation issues and 627 (96.6%) non-separation issues.

**Appeals** – 397 appeal decisions were processed with the Board of Review in October 2018. Of the 397 processed, 323 (81.4%) were filed by UI applicants and 74 (18.6%) were filed by employers. The Board upheld the director's decision in nearly two-thirds of the cases.
