Weekly Update of Claims Activity

Week Ending: November 11, 2017

Unemployment Insurance

Initial Claims – 1,031 initial claims were processed during the week ending 11/11/17, an increase of 157 from the previous week, and an increase 40 from a year ago. The number of initial claims filed to date is down 8.3 percent from last year and down 14.4 percent from two years ago.

Continued Claims - 6,152 continued claims were processed during the week of 11/11/17, an increase of 123 from the previous week and a decrease of 151 from a year ago. The number of continued claims filed to date is down 2.0 percent from last year and down 9.9 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 27 initial claims and 187 continued claims were processed. An estimated 8 layoffs were prevented this week, as a result of Workshare.

Exhaustions – 151 individuals exhausted their regular payments this week an increase of 4 from the previous week and a decrease of 7 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 901 initial claims and 7,347 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$499 per week. Rhode Island is currently paying an average of 10.3 weeks per new claim. To date there have been 41,308 TDI initial claims filed.

Temporary Caregiver Insurance – Of the 901 TDI initial claims, 226 (25.1%) were TCI Claims. This week 475 TCI payments were issued totaling \$272,483. The average weekly TCI payment was \$574. Of the 41,308 TDI claims filed in 2017, 9,661 or 23.4% were TCI claims.
