Weekly Update of Claims Activity

Week Ending: October 14, 2017

Unemployment Insurance

Initial Claims – 716 initial claims were processed during the week ending 10/14/17, a decrease of 46 from the previous week, and an increase of 8 from a year ago. The number of initial claims filed to date is down 8.3 percent from last year and down 14.5 percent from two years ago.

Continued Claims – 5,922 continued claims were processed during the week of 10/14/17, a decrease of 79 from the previous week and a decrease of 408 from a year ago. The number of continued claims filed to date is down 1.9 percent from last year and down 9.9 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 26 initial claims and 146 continued claims were processed. An estimated 9 layoffs were prevented this week, as a result of Workshare.

Exhaustions – 143 individuals exhausted their regular payments this week a decrease of 1 from the previous week and a decrease of 9 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 851 initial claims and 6,615 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$496 per week. Rhode Island is currently paying an average of 10.4 weeks per new claim. To date there have been 37,654 TDI initial claims filed.

Temporary Caregiver Insurance – Of the 851 TDI initial claims, 199 (23.1%) were TCI Claims. This week 422 TCI payments were issued totaling \$235,457. The average weekly TCI payment was \$558. Of the 37,654 TDI claims filed in 2017, 8,724 or 23.2% were TCI claims.
