Weekly Update of Claims Activity

Week Ending: September 23, 2017

Unemployment Insurance

Initial Claims – 782 initial claims were processed during the week ending 9/23/17, a decrease of 36 from the previous week, and an increase of 105 from a year ago. The number of initial claims filed to date is down 8.6 percent from last year and down 14.5 percent from two years ago.

Continued Claims – 6,173 continued claims were processed during the week of 9/23/17, a decrease of 55 from the previous week and a decrease of 448 from a year ago. The number of continued claims filed to date is down 1.7 percent from last year and down 9.9 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 8 initial claims and 325 continued claims were processed. An estimated 2 layoffs were prevented this week, as a result of Workshare.

Exhaustions – 116 individuals exhausted their regular payments this week a decrease of 13 from the previous week and a decrease of 35 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 941 initial claims and 8,344 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$505 per week. Rhode Island is currently paying an average of 10.4 weeks per new claim. To date there have been 34,858 TDI initial claims filed.

Temporary Caregiver Insurance – Of the 941 TDI initial claims, 258 (27.4%) were TCI Claims. This week 592 TCI payments were issued totaling \$330,455. The average weekly TCI payment was \$558. Of the 34,858 TDI claims filed in 2017, 8,050 or 23.1% were TCI claims.
