Weekly Update of Claims Activity

Week Ending: July 15, 2017

Unemployment Insurance

Initial Claims – 959 initial claims were processed during the week ending 7/15/17, a decrease of 404 from the previous week, and a decrease of 164 from a year ago. The number of initial claims filed to date is down 9.7 percent from last year and down 15.2 percent from two years ago.

- **Continued Claims** 9,991 continued claims were processed during the week of 7/15/17, an increase of 800 from the previous week and a decrease of 44 from a year ago. The number of continued claims filed to date is down 1.1 percent from last year and down 11.0 percent from two years ago.
- **Workshare** gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 32 initial claims and 235 continued claims were processed. An estimated 9 layoffs were prevented this week, as a result of Workshare.

Exhaustions – 187 individuals exhausted their regular payments this week an increase of 56 from the previous week and a decrease of 4 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 1,050 initial claims and 7,652 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$495 per week. Rhode Island is currently paying an average of 10.4 weeks per new claim. To date there have been 25,449 TDI initial claims filed.

Temporary Caregiver Insurance – Of the 1,050 TDI initial claims, 206 (19.6%) were TCI Claims. This week 394 TCI payments were issued totaling \$216,987. The average weekly TCI payment was \$551. Of the 25,449 TDI claims filed in 2017, 5,572 or 21.9% were TCI claims.
