Weekly Update of Claims Activity

Week Ending: April 22, 2017

Unemployment Insurance

Initial Claims – 2,222 initial claims were processed during the week ending 4/22/17, an increase of 875 from the previous week, and a decrease of 549 from a year ago. The number of initial claims filed to date is down 13.8 percent from last year and down 19.9 percent from two years ago.

Continued Claims – 8,945 continued claims were processed during the week of 4/22/17, a decrease of 855 from the previous week and a decrease of 258 from a year ago. The number of continued claims filed to date is up 0.4 percent from last year and down 12.4 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 14 initial claims and 414 continued claims were processed. An estimated 3 layoffs were prevented this week, as a result of Workshare.

Exhaustions – 151 individuals exhausted their regular payments this week, a decrease 32 of from the previous week and a decrease of 56 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 887 initial claims and 7,062 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$493 per week. Rhode Island is currently paying an average of 10.5 weeks per new claim. To date there have been 14,393 TDI initial claims filed.

Temporary Caregiver Insurance – Of the 887 TDI initial claims, 240 (27.1%) were TCI Claims. This week 464 TCI payments were issued totaling \$248,261. The average weekly TCI payment was \$535. Of the 14,393 TDI claims filed in 2017, 3,114 or 21.6% were TCI claims.
