Weekly Update of Claims Activity

Week Ending: January 21, 2017

Unemployment Insurance

Initial Claims – 1,369 initial claims were processed during the week ending 1/21/17, a decrease of 783 from the previous week, and a decrease of 484 from a year ago.

Continued Claims – 12,075 continued claims were processed during the week of 1/21/17, an increase of 406 from the previous week and an increase of 339 from a year ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 4 initial claims and 84 continued claims were processed.

Exhaustions – 132 individuals exhausted their regular payments this week, a decrease of 57 from the previous week and a decrease of 11 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 875 initial claims and 6,187 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$494 per week. Rhode Island is currently paying an average of 10.5 weeks per new claim. To date there have been 2,683 TDI initial claims filed.

Temporary Caregiver Insurance – Of the 875 TDI initial claims, 198 (22.6%) were TCI Claims. This week 363 TCI payments were issued totaling \$186,181. The average weekly TCI payment was \$513. Of the 2,683 TDI claims filed in 2017, 585 or 21.8% were TCI claims.
