Weekly Update of Claims Activity

Week Ending: November 12, 2016

## **Unemployment Insurance**

**Initial Claims** – 991 initial claims were processed during the week ending 11/12/16, a decrease of 14 from the previous week, and a decrease of 71 from a year ago. The number of initial claims filed to date is down 6.1 percent from last year and down 15.9 percent from two years ago.

**Continued Claims** - 6,303 continued claims were processed during the week of 11/12/16, an increase of 14 from the previous week and a decrease of 678 from a year ago. The number of continued claims filed to date is down 8.3 percent from last year and down 20.2 percent from two years ago.

**Workshare** – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 2 initial claims and 273 continued claims were processed. An estimated 1 layoff was prevented this week, as a result of Workshare.

**Exhaustions** – 158 individuals exhausted their regular payments this week, an increase of 4 from the previous week and an increase of 25 from a year ago.

## Temporary Disability Insurance

**Temporary Disability Insurance** – 705 initial claims and 6,054 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$495 per week. Rhode Island is currently paying an average of 10.5 weeks per new claim. To date there have been 42,315 TDI initial claims filed.

**Temporary Caregiver Insurance** – Of the 705 TDI initial claims, 162 (23.0%) were TCI Claims. This week 366 TCI payments were issued totaling \$189,012. The average weekly TCI payment was \$516. Of the 42,315 TDI claims filed in 2016, 8,565 or 20.2% were TCI claims.
