Weekly Update of Claims Activity

Week Ending: July 23, 2016

Unemployment Insurance

Initial Claims – 814 initial claims were processed during the week ending 7/22/16, a decrease of 309 from the previous week, and an increase of 59 from a year ago. The number of initial claims filed to date is down 5.2 percent from last year and down 15.6 percent from two years ago.

Continued Claims – 9,672 continued claims were processed during the week of 7/22/16, a decrease of 363 from the previous week and a decrease of 442 from a year ago. The number of continued claims filed to date is down 10.1 percent from last year and down 21.9 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 48 initial claims and 369 continued claims were processed. An estimated 11 layoffs were prevented this week, as a result of Workshare.

Exhaustions – 163 individuals exhausted their regular payments this week, a decrease 28 from the previous week and a decrease of 25 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 821 initial claims and 7,158 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$480 per week. Rhode Island is currently paying an average of 10.5 weeks per new claim. To date there have been 27,496 TDI initial claims filed.

Temporary Caregiver Insurance – Of the 821 TDI initial claims, 195 (23.8%) were TCI Claims. This week 466 TCI payments were issued totaling \$257,381. The average weekly TCI payment was \$552. Of the 27,496 TDI claims filed in 2016, 5,238 or 19.1% were TCI claims.
