Weekly Update of Claims Activity

Week Ending: July 9, 2016

Unemployment Insurance

Initial Claims – 1,129 initial claims were processed during the week ending 7/9/16, a decrease of 464 from the previous week, and an increase of 168 from a year ago. The number of initial claims filed to date is down 5.0 percent from last year and down 16.0 percent from two years ago.

Continued Claims – 9,339 continued claims were processed during the week of 7/9/16, an increase of 353 from the previous week and a decrease of 610 from a year ago. The number of continued claims filed to date is down 10.6 percent from last year and down 22.4 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 53 initial claims and 264 continued claims were processed. An estimated 11 layoffs were prevented this week, as a result of Workshare.

Exhaustions – 173 individuals exhausted their regular payments this week, an increase of 1 from the previous week and an increase of 8 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 627 initial claims and 6,789 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$481 per week. Rhode Island is currently paying an average of 10.4 weeks per new claim. To date there have been 25,777 TDI initial claims filed.

Temporary Caregiver Insurance – Of the 627 TDI initial claims, 157 (25.0%) were TCI Claims. This week 276 TCI payments were issued totaling \$137,412. The average weekly TCI payment was \$498. Of the 25,777 TDI claims filed in 2016, 4,821 or 18.7% were TCI claims.
