Weekly Update of Claims Activity

Week Ending: July 2, 2016

Unemployment Insurance

Initial Claims – 1,593 initial claims were processed during the week ending 7/2/16, a decrease of 702 from the previous week, and a decrease of 595 from a year ago. The number of initial claims filed to date is down 5.6 percent from last year and down 15.9 percent from two years ago.

Continued Claims – 8,986 continued claims were processed during the week of 7/2/16, an increase of 1,481 from the previous week and a decrease of 38 from a year ago. The number of continued claims filed to date is down 10.7 percent from last year and down 22.4 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 22 initial claims and 508 continued claims were processed. An estimated 6 layoffs were prevented this week, as a result of Workshare.

Exhaustions – 172 individuals exhausted their regular payments this week, an increase of 16 from the previous week and a decrease of 24 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 1,011 initial claims and 8,063 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$480 per week. Rhode Island is currently paying an average of 10.3 weeks per new claim. To date there have been 25,150 TDI initial claims filed.

Temporary Caregiver Insurance – Of the 1,011 TDI initial claims, 188 (18.6%) were TCI Claims. This week 564 TCI payments were issued totaling \$310,024. The average weekly TCI payment was \$550. Of the 25,150 TDI claims filed in 2016, 4,664 or 18.5% were TCI claims.
