Weekly Update of Claims Activity

Week Ending: February 6, 2016

Unemployment Insurance

Initial Claims – 2,168 initial claims were processed during the week ending 2/6/16, an increase of 788 from the previous week, and an increase of 91 from a year ago.

Continued Claims – 12,771 continued claims were processed during the week of 2/6/16, an increase of 440 from the previous week and a decrease of 1,460 from a year ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 22 initial claims and 229 continued claims were processed. An estimated 5 layoffs were prevented this week, as a result of Workshare.

Exhaustions – 138 individuals exhausted their regular payments this week, a decrease of 20 from the previous week and a decrease of 49 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 1,186 initial claims and 8,000 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$476 per week. Rhode Island is currently paying an average of 10.3 weeks per new claim. To date there have been 5,462 TDI initial claims filed.

Temporary Caregiver Insurance – Of the 1,186 TDI initial claims, 183 (15.4%) were TCI Claims. This week 539 TCI payments were issued totaling \$277,765. The average weekly TCI payment was \$515. Of the 5,462 TDI claims filed in 2016, 870 or 15.9% were TCI claims.
