Weekly Update of Claims Activity

Week Ending: January 30, 2016

Unemployment Insurance

Initial Claims – 1,380 initial claims were processed during the week ending 1/30/16, a decrease of 473 from the previous week, and an increase of 100 from a year ago.

Continued Claims – 12,331 continued claims were processed during the week of 1/30/16, an increase of 595 from the previous week and a decrease of 1,095 from a year ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 4 initial claims and 218 continued claims were processed. An estimated 2 layoffs were prevented this week, as a result of Workshare.

Exhaustions – 158 individuals exhausted their regular payments this week, an increase of 15 from the previous week and a decrease of 52 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 827 initial claims and 8,203 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$468 per week. Rhode Island is currently paying an average of 10.4 weeks per new claim. To date there have been 4,276 TDI initial claims filed.

Temporary Caregiver Insurance – Of the 827 TDI initial claims, 200 (24.2%) were TCI Claims. This week 434 TCI payments were issued totaling \$221,301. The average weekly TCI payment was \$510. Of the 4,276 TDI claims filed in 2016, 687 or 16.1% were TCI claims.
