Weekly Update of Claims Activity

Week Ending: May 17, 2014

Unemployment Insurance

Initial Claims – 982 initial claims were processed during the week ending 5/17/14, a decrease of 165 from the previous week, and a decrease of 95 from a year ago. The number of initial claims filed to date is down 5.5 percent from last year and down 5.7 percent from two years ago.

Continued Claims – 9,842 continued claims were processed during the week of 5/17/14, a decrease of 480 from the previous week and a decrease of 1,103 from a year ago. The number of continued claims filed to date is down 5.1 percent from last year and down 12.9 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 3 initial claims and 246 continued claims were processed. There was 1 layoff prevented this week, as a result of Workshare.

Exhaustions – 325 individuals exhausted their regular payments this week, a decrease of 14 from the previous week and a decrease of 44 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 592 initial claims and 7,206 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$450 per week. Rhode Island is currently paying an average of 10.8 weeks per new claim.

Temporary Caregiver Insurance – Of the 592 TDI initial claims, 112 (18.9%) were TCI Claims. This week 309 TCI payments were issued totaling \$158,741. The average weekly TCI payment was \$514.
