Weekly Update of Claims Activity

Week Ending: April 26, 2014

Unemployment Insurance

Initial Claims – 2,270 initial claims were processed during the week ending 4/26/14, an increase of 1,069 from the previous week, and an increase of 531 from a year ago. The number of initial claims filed to date is down 7.4 percent from last year and down 5.3 percent from two years ago.

Continued Claims – 11,307 continued claims were processed during the week of 4/26/14, a decrease of 937 from the previous week and a decrease of 2,814 from a year ago. The number of continued claims filed to date is down 5.5 percent from last year and down 12.7 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 8 initial claims and 298 continued claims were processed. There were 3 layoffs prevented this week, as a result of Workshare.

Exhaustions – 291 individuals exhausted their regular payments this week, a decrease of 15 from the previous week and a decrease of 65 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 808 initial claims and 6,816 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$441 per week. Rhode Island is currently paying an average of 10.7 weeks per new claim.
