Weekly Update of Claims Activity

Week Ending: February 9, 2013

Unemployment Insurance

Initial Claims – 1,803 initial claims were processed during the week ending 2/9/13, an increase of 186 from the previous week, and an increase of 8 from a year ago.

Continued Claims – 17,150 continued claims were processed during the week of 2/9/13, an increase of 42 from the previous week and a decrease of 2,094 from a year ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 18 initial claims and 505 continued claims were processed. An estimated 6 layoffs were prevented this week, as a result of Workshare.

Emergency Unemployment Compensation 08 – EUC08, which became effective July 6, 2008, provides up to 53 weeks of federally funded benefits to eligible individuals who exhausted their UI claims. This week there were 317 new EUC08 claims processed and 7,462 continued claims processed (2,704 under tier I, 2,479 under tier II, 1,195 under tier III and 1,084 under tier IV).

Exhaustions – 428 individuals exhausted their regular payments this week, an increase of 139 from a year ago. There were 148 individuals that exhausted EUC08.

Temporary Disability Insurance

Temporary Disability Insurance – 625 initial claims and 6,829 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$448 per week. Rhode Island is currently paying an average of 10.7 weeks per new claim.
