Weekly Update of Claims Activity

Week Ending: January 26, 2013

Unemployment Insurance

Initial Claims – 1,553 initial claims were processed during the week ending 1/26/13, a decrease of 867 from the previous week, and a decrease of 402 from a year ago.

Continued Claims – 16,553 continued claims were processed during the week of 1/26/13, a decrease of 713 from the previous week and a decrease of 2,417 from a year ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 48 initial claims and 561 continued claims were processed. An estimated 12 layoffs were prevented this week, as a result of Workshare.

Emergency Unemployment Compensation 08 – EUC08, which became effective July 6, 2008, provides up to 53 weeks of federally funded benefits to eligible individuals who exhausted their UI claims. This week there were 215 new EUC08 claims processed and 7,143 continued claims processed (2,524 under tier I, 2,395 under tier II, 1,121 under tier III and 1,103 under tier IV).

Exhaustions – 300 individuals exhausted their regular payments this week, a decrease of 51 from a year ago. There were 139 individuals that exhausted EUC08.

Temporary Disability Insurance

Temporary Disability Insurance – 555 initial claims and 6,841 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$445 per week. Rhode Island is currently paying an average of 10.9 weeks per new claim.
