Monthly Update

Month Ending: August 31, 2017

Unemployment Insurance

Initial Claims – 3,717 initial claims were processed during the month of August, a decrease of 365 (-8.9%) from the previous month, and a decrease of 478 (-11.4%) from a year ago. Of the 2,310 monetary determinations issued in August, 188 (8.1%) were monetarily ineligible.

Weeks Claimed – 37,689 weeks claimed were processed during the month of August, a decrease of 8,900 (-19.1%) from the previous month and a decrease of 10,362 (-21.6%) from a year ago. There were 36,118 payments made in August, which resulted in payments totaling \$11.6 million. There were 2,767 (7.7%) partial payments issued in August 2017 compared to 3,290 (7.4%) last year. The average weekly benefit payment was \$322. The number of weekly benefit payments is averaging 15.2 weeks per claim.

Workshare – 40 initial claims were processed for Workshare benefits this month, a decrease of 58 (-59.2%) from the previous month and a decrease of 2 (-4.8%) from July 2016. It is estimated that 12 layoffs were averted this month as a result of Rhode Island's Workshare program.

First and Final Claims – 1,723 first payments and 608 final payments were issued in August 2017. The current exhaustion duration ratio is 28.3 percent.

Non-monetary Determinations – 2,103 non-monetary determinations were issued during the month of August 2017. Of the 2,103 determinations, 1,195 (56.8%) were separation issues and 908 (43.2%) were non-separation issues. Denials were issued for 512 (42.8%) separation issues and 813 (89.5%) non-separation issues.

Appeals – 449 appeal decisions were processed with the Board of Review in August 2017. Of the 449 processed, 363 (80.8%) were filed by UI applicants and 86 (19.2%) were filed by employers. The Board upheld the director's decision in nearly two-thirds of the cases.
