Monthly Update

Month Ending: September 30, 2016

Unemployment Insurance

- **Initial Claims** 3,178 initial claims were processed during the month of September, a decrease of 1,017 (-24.2%) from the previous month, and a decrease of 601 (-15.9%) from a year ago. Of the 1,993 monetary determinations issued in September, 198 (9.9%) were monetarily ineligible.
- Weeks Claimed 29,276 weeks claimed were processed during the month of September, a decrease of 18,775 (-39.1%) from the previous month and a decrease of 124 (-0.4%) from a year ago. There were 26,700 payments made in September, which resulted in payments totaling \$9.2 million. There were 2,294 (8.6%) partial payments issued in September 2016 compared to 2,110 (7.7%) last year. The average weekly benefit payment was \$344. The number of weekly benefit payments is averaging 15.0 weeks per claim.
- Workshare 168 initial claims were processed for Workshare benefits this month, an increase of 126 (300.0%) from the previous month and an increase of 16 (10.5%) from September 2015. It is estimated that 54 layoffs were averted this month as a result of Rhode Island's Workshare program.
- First and Final Claims 1,558 first payments and 622 final payments were issued in September 2016. The current exhaustion duration ratio is 29.7 percent.
- Non-monetary Determinations 1,985 non-monetary determinations were issued during the month of September 2016. Of the 1,985 determinations, 1,187 (59.8%) were separation issues and 798 (40.2%) were non-separation issues. Denials were issued for 515 (43.4%) separation issues and 689 (86.3%) non-separation issues.

Appeals – 466 appeal decisions were processed with the Board of Review in September 2016. Of the 466 processed, 354 (76.0%) were filed by UI applicants and 112 (24.0%) were filed by employers. The Board upheld the director's decision in nearly two-thirds of the cases.
