## Monthly Update

Month Ending: January 31, 2016

## **Unemployment Insurance**

- **Initial Claims** 8,409 initial claims were processed during the month of January, a decrease of 273 (-3.1%) from the previous month, and a decrease of 569 (-6.3%) from a year ago. Of the 5,911 monetary determinations issued in January, 300 (5.1%) were monetarily ineligible.
- Weeks Claimed 50,480 weeks claimed were processed during the month of January, an increase of 11,290 (28.8%) from the previous month and a decrease of 8,701 (-14.7%) from a year ago. There were 44,184 payments made in January, which resulted in payments totaling \$14.6 million. There were 2,638 (6.0%) partial payments issued in January 2016 compared to 3,376 (6.5%) last year. The average weekly benefit payment was \$331. The number of weekly benefit payments is averaging 15.7 weeks per claim.
- Workshare 23 initial claims were processed for Workshare benefits this month, a decrease of 39 (-62.9%) from the previous month and a decrease of 62 (-72.9%) from January 2015. It is estimated that 8 layoffs were averted this month as a result of Rhode Island's Workshare program.
- **First and Final Claims** 4,752 first payments and 693 final payments were issued in January 2016. The current exhaustion duration ratio is 30.0 percent.
- Non-monetary Determinations 1,330 non-monetary determinations were issued during the month of January 2016. Of the 1,330 determinations, 746 (56.1%) were separation issues and 584 (43.9%) were non-separation issues. Denials were issued for 305 (40.9%) separation issues and 523 (89.6%) non-separation issues.
- Appeals 420 appeal decisions were processed with the Board of Review in January 2016. Of the 420 processed, 325 (77.4%) were filed by UI applicants and 95 (22.6%) were filed by employers. The Board upheld the director's decision in nearly two-thirds of the cases.
