## Monthly Update

Month Ending: November 30, 2014

## **Unemployment Insurance**

- **Initial Claims** 5,149 initial claims were processed during the month of November, an increase of 408 (8.6%) from the previous month, and a decrease of 535 (-9.4%) from a year ago. Of the 3,121 monetary determinations issued in November, 338 (10.8%) were monetarily ineligible.
- Weeks Claimed 34,138 weeks claimed were processed during the month of November, an increase of 789 (2.4%) from the previous month and a decrease of 7,730 (-18.5%) from a year ago. There were 29,778 payments made in November, which resulted in payments totaling \$9.8 million. There were 2,480 (8.3%) partial payments issued in November 2014 compared to 3,776 (10.0%) last year. The average weekly benefit payment was \$328. The number of weekly benefit payments is averaging 16.3 weeks per claim.
- Workshare 68 initial claims were processed for Workshare benefits this month, a decrease of 14 (-17.1%) from the previous month and an increase of 18 (36.0%) from November 2013. It is estimated that 15 layoffs were averted this month as a result of Rhode Island's Workshare program.
- **First and Final Claims** 1,921 first payments and 838 final payments were issued in November 2014. The current exhaustion duration ratio is 38.2 percent.
- Non-monetary Determinations 1,299 non-monetary determinations were issued during the month of November 2014. Of the 1,299 determinations, 790 (60.8%) were separation issues and 509 (39.2%) were non-separation issues. Denials were issued for 314 (39.7%) separation issues and 482 (94.7%) non-separation issues.
- Appeals 293 appeal decisions were processed with the Board of Review in November 2014. Of the 293 processed, 247 (84.3%) were filed by UI applicants and 46 (15.7%) were filed by employers. The Board upheld the director's decision in nearly two-thirds of the cases.
