Monthly Update

Month Ending: July 31, 2014

Unemployment Insurance

- **Initial Claims** 5,633 initial claims were processed during the month of July, a decrease of 1,470 (-20.7%) from the previous month, and a decrease of 1,742 (-23.6%) from a year ago. Of the 3,760 monetary determinations issued in July, 319 (8.5%) were monetarily ineligible.
- Weeks Claimed 48,642 weeks claimed were processed during the month of July, an increase of 1,202 (2.5%) from the previous month and a decrease of 10,902 (-18.3%) from a year ago. There were 43,467 payments made in July, which resulted in payments totaling \$13.5 million. There were 3,319 (7.6%) partial payments issued in July 2014 compared to 4,746 (8.8%) last year. The average weekly benefit payment was \$310. The number of weekly benefit payments is averaging 16.2 weeks per claim.
- Workshare 88 initial claims were processed for Workshare benefits this month, a decrease of 54 (-38.0%) from the previous month and a decrease of 71 (-44.7%) from July 2013. It is estimated that 21 layoffs were averted this month as a result of Rhode Island's Workshare program.
- **First and Final Claims** 3,246 first payments and 1,002 final payments were issued in July 2014. The current exhaustion duration ratio is 39.7 percent.
- **Non-monetary Determinations** 1,743 non-monetary determinations were issued during the month of July 2014. Of the 1,743 determinations, 969 (55.6%) were separation issues and 774 (44.4%) were non-separation issues. Denials were issued for 398 (41.1%) separation issues and 544 (70.3%) non-separation issues.
- Appeals 468 appeal decisions were processed with the Board of Review in July 2014. Of the 468 processed, 396 (84.6%) were filed by UI applicants and 72 (15.4%) were filed by employers. The Board upheld the director's decision in nearly two-thirds of the cases.
