# **TDI Monthly Update**

September 2014

## **Temporary Disability Insurance**

- Initial Claims A total of 4,055 initial applications for Temporary Insurance Benefits (TDI) were filed during the month of September. Approximately 85 percent of the applications were approved and 15 percent were denied.
- Payments During the period 33,861 payments totaling \$15.0 million were issued. TDI payments averaged \$443 per week.

# **Temporary Caregiver Insurance**

- **TCI claims** Of the 4,055 initial TDI applications filed during the month of September, 574 (14.2%) were Temporary Caregiver Insurance benefits (TCI). A total of 458 (79.8%) were approved and 116 (20.2%) were denied.
- **Type of Claim** Nearly one-quarter (22.5%) of the TCI claims approved were for care of a family member and more than three-quarters (77.5%) were for bonding with a child.
- **Reason for Claim** The majority (76.0%) of TCI Claims approved were for bonding with a new born, followed by care of a spouse (10.7%) and care of a parent at (6.3%).
- **TCI Payments** During the month of September; 1,619 TCI payments totaling over \$831 thousand were issued. TCI payments averaged \$513 per week.

To Date – 3,851 TCI initial claims have been filed accounting for 10.7 percent of the 35	,920 TDI applications filed.
There have been 9,657 TCI payments issued to date totaling \$4,878,696.
