

Introduction

Rhode Island Commuting Patterns

Based on data collected from the Census Bureau's 2016-2020 American Community Survey, *Rhode Island Commuting Patterns* provides journey-to-work statistics for Rhode Island counties. Data is divided into two categories: Where Rhode Island Residents Work and Where Rhode Island Workers Live. Not surprisingly, most Rhode Island residents work in Providence County (50.1%). Commuting patterns also supply information on resident outflow to neighboring states for employment. Of the five Rhode Island counties, Washington County has the highest percentage (8.2%) of residents who commute to Connecticut for work, while Providence County has the highest percentage (17.7%) of residents working in Massachusetts.

Rhode Island workers are most likely to live in Providence County (49.7%), followed by Kent County (15.8%). There are 59,453 residents from other states who commute into Rhode Island for employment. Washington County attracts the greatest percentage (5.3%) of Connecticut residents into its county for work, while Newport County draws 13.2 percent of its workforce from Massachusetts.

Rhode Island exports 82,800 residents to other states or countries for work, while Rhode Island imports only 59,453 workers from other states.

Definitions

Commute to work - Includes data on where people work, how they get to work, how long it takes to get from their home to their usual workplace, when they leave home to go to their usual workplace, and carpooling. Data are estimates of people 16 years old and over who were both employed and at work during the reference week (including people in the armed forces). Source: US Census Bureau, 2016-2020 5-Year American Community Survey Commuting Flows

Income of Families - In compiling statistics on family income, the incomes of all members 15 years old and over in each family are summed and treated as a single amount. Family households include a householder and one or more persons living in the same household who are related to the household by birth, marriage or adoption. All persons in the household who are related to the householder are regarded as members of his or her family. Not all households contain families since a household may comprise a group of unrelated individuals or one person living alone. *Source: US Census Bureau, 2018-2022 American Community Survey 5-Year Estimates, Table S1901*

Income of Households - Includes the income of the householder and all other persons 15 years old and over in the household, whether related to the householder or not. Households include all the persons who occupy a housing unit – a house, an apartment, a mobile home, a group of rooms or a single room that is occupied as separate living quarters. Because many households consist of only one person, average household income is usually less than average family income. *Source: US Census Bureau, 2018-2022 American Community Survey 5-Year Estimates, Table S1901*

Unemployed - All civilians 16 years old and over were classified as unemployed if they were neither "at work" nor "with a job but not at work" during the reference week, were looking for work during the last four weeks, and were available to start a job. Also included as unemployed were civilians 16 years old and over who: did not work at all during the reference week, were on temporary layoff from a job, had been informed that they would be recalled to work within the next six months or had been given a date to return to work, and were available to return to work during the reference week, except for temporary illness. The unemployment rate is determined by dividing the number unemployed by the civilian labor force. *Source: US Bureau of Labor Statistics, 2023 Annual Average Unemployment Rate*

Educational Attainment - Level of education completed by all individuals aged 25 years and older. *Source: US Census Bureau, 2018-2022 American Community Survey 5-Year Estimates, Table S1501*

Connecticut Change from Counties to Planning Regions

Almost all functions of county government were abolished in Connecticut in 1960. Due to this, Connecticut has decided to officially migrate from using legacy County designations to county-equivalents (Planning Regions) based on Connecticut's Councils of Government for statistical purposes. Connecticut will therefore consist of nine Planning Regions instead of eight Counties.
