

Social Distancing and the COVID-19 Crisis

Rhode Island experienced record-breaking employment in February 2020, with an estimated 507,200 RI-based jobs, the highest job count on record. Several economic sectors were at all-time highs and the state's unemployment rate was at a thirty year low. But, by March, the COVID Crisis had come to Rhode Island, thousands of workers were suddenly unemployed as the state experienced recession level job losses of 108,000 in just two months resulting from the coronavirus pandemic.

On March 13th, Rhode Island casinos closed; a few days later, day care centers were ordered closed. restaurants were closed to take-out orders only, and social gatherings were limited to no more than ten people. As the month continued, fitness centers, hair & nail salons, recreation & entertainment facilities, and all non-essential retail were all ordered to close. Elective surgeries were canceled, and medical appointments were limited to telephone and video interviews all in an effort to stop the spread of the COVID-19. Rhode Island's "Stay at Home" order would continue until May 9, 2020.

Between March 8 and May 9, 2020, the Department of Labor and Training recorded 162,670 initial claim filings for Unemployment Insurance Benefits, an average


of 18,074 initial claim filings per week. Prior to the crisis the number of initial claims filed in 2020 averaged 1,222 per week. Over 95 percent of the initial claims filed were related to COVID-19.

Initial Claims were filed by workers employed in all economic sectors with the largest number of initial claims being filed by those employed in sectors most severely impacted by "social distancing" policies first announced on March 13, 2020. Nearly half of the initial claims filed during the two-month period were filed by workers employed in one of the state's three largest economic sectors. Accommodation & Food Services (21.5%) accounted for the largest number of initial claims, followed by Health Care & Social Assistance (15.7%) and Retail Trade (11.8%). Industries in all three of these sectors were either totally or partial impacted by closures necessitated by social distancing.

Industry Sectors

The Accommodation & Foods Services sector with nearly 35,000 initial claims recorded the most initial claims received during the period accounting for 21.5 percent of the total initial claims filed. Over 60 percent of the workers employed in this sector's workforce filed a claim. Industries in this sector with workforces that were the most severely impacted by the social distancing orders include:

- Full Service Restaurants 17,368 initial claims were filed by workers employed in this industry, accounting for 10.7 percent of the total initial claims filed and three-quarters of the industry's workforce.
- Hotels, Casino Hotels & Motels 5,766 initial claims were filed by workers employed in this industry, accounting for 3.5 percent of the total initial claims filed and three-quarters of the industry's workforce.
- Limited Service Restaurants 4,866 initial claims were filed by workers employed in this industry, accounting for 3.0 percent of the total initial claims filed and 44 percent of the industry's workforce.
- Drinking Places/Bars 1,500 initial claims were filed by workers employed in this industry, accounting for 1.3 percent of the total initial claims filed and 64 percent of the industry's workforce.
- Food Service Contractors 2,571 initial claims were filed by workers employed in this industry accounting for 1.6 percent of the total initial claims filed and two-thirds of the industry's workforce.



Health Care & Social Assistance with 25,569 initial claims accounted for 15.7 percent of the total initial claims filed and nearly one-third of the sector's total workforce. Several industries within this sector were totally or partially impacted by the social distancing guidelines as Day Care Centers were order closed, medical appointments were limited to telephone and video interviews, and elective surgeries were canceled.

- Ambulatory Health Services which includes offices of medical doctors, dentists, optometrists, and chiropractors reported 11,765 initial claims accounting for 7.2 percent of the total initial claims filed and 44 percent of the workforce.
- Social Assistance which includes Day Care Centers reported 6,097 initial claims filed, accounting for 3.7 percent of the total initial claims filed and 47 percent of the industry's workforce. Nearly 95 percent of the workers (3,425) employed in Day Care Centers filed initial claims.

The Retail Trade sector recorded 19,229 initial claims, the third largest number of initial claims filed accounting for 11.8 percent of the total initial claims filed. Non-essential retail establishments were ordered to close on March 30 affecting many industries within this economic sector. The industries that were most severely impacted include:

- Clothing & Accessories Stores 3,425 initial claims were filed by workers employed in this industry, accounting for 2 percent of the total initial claims filed and 88 percent of the industry's workforce.
- Motor Vehicle & Parts Dealers 3,317 initial claims were filed by workers employed in this industry, accounting for 2 percent of the total initial claims filed and over half of the industry's workforce.
- Miscellaneous Retail Stores such as Florists, Gift & Novelty, Office Supply and Used Merchandise-recorded 1,902 initial claims accounting for 1.2 percent of the total initial claims filed and 63 percent of the industry's workforce.
- Department Stores 1,932 initial claims were filed by workers employed in this industry accounting for 1.2 percent of the total initial claims filed and over half of the industry's workforce.
- Furniture Stores & Home Furnishing 1,074 initial claims were filed by workers employed in this industry, accounting for less than 1 percent of the total initial claims filed but over half 80 percent of the industry's workforce.

A total of 8,825 initial claims were filed by workers in the Other Services sector accounting by for 5.4 percent of the total initial claims filed and 47.4 percent of the sector's workforce. Personal & Laundry services which includes hair salons and barbershops recorded over half the initial claims filed from this sector. A total of 2,114 initial claims were filed by workers in Personal Care Services (i.e. hair, nail and tanning salons, barbershops, massage and tattoo parlors, and diet centers) the hardest hit industry group in the sector accounting for 1.3 percent of the total initial claims filed and nearly 90 percent of the industry's workforce. Note: These claims were filed by employees of the establishments; owners, and those who rent chairs would be counted among the self-employed.


Schools were closed on March 13th resulting in nearly 6,700 initial claims being filed by employees in the Educational Services (Public and Private) sector accounting for 4.1 percent of the total initial claims filed. Just 14 percent of the sector's workforce filed claims as the transition to virtual learning allowed much of the sector's workforce to work from home. Also affected by the closing of schools were employees in the School & Bus Transportation industry. Initial claims were received from nearly 2,700 of the industry's employees accounting for 99 percent of the industry's workforce which is included in the Transportation & Utilities sector of the economy.

Other sectors of the economy not directly affected by social distancing had also seen increases in initial claims filings as availability issues associated with collecting benefits were relaxed allowing workers who were required to quarantine, care for out-of-school children or felt at risk due to age or medical conditions, to collect benefits.

Occupations

In terms of Occupations, workers employed in lower wage occupations had been more impacted by the social distancing guidelines than those whose jobs pay average and higher wages. While occupations with median wages below \$20 an hour employ 57.3 percent of all workers employed in Rhode-Island based jobs, nearly two-thirds (66.0%) of the initial claims had been filed by workers employed in occupations paying less than \$20 an hour.

Food Preparation & Serving workers employed mainly in the Food Services & Restaurant industry accounted for more initial claims than any other occupational group. Nearly 27,000 initial claims had been filed by workers employed in these occupations accounting for 16.5 percent of the total initial claims filed and 54.3 percent of the occupational group's workforce. Workers in this occupational group earned an average of \$11.98 per hour, a weekly average of \$479 for a worker employed full-time. The average weekly benefit amount for full-time-workers employed in these occupations was estimated to be \$240 per week. The federal weekly stimulus payment of \$600 per week would raise that amount to \$840 a week, through July.



Office & Administrative Support Occupations which are found in many sectors of the economy accounted for 13 percent of the initial claims filed. Workers employed full-time in these occupations earn an average of \$18.89 an hour, a weekly average of \$756 per week for a full-time worker. The average weekly benefit rate for these full-workers was estimated to be \$378 a week plus the \$600 federal stimulus.

Workers employed in Management occupations have the highest median wage in Rhode Island with half the workers earning over \$58.96 per hour or \$2,358 per week. Most the workers unemployed from this occupational group would collect the state maximum benefit rate of \$586 per week. The federal weekly stimulus payment of \$600 per week raised this amount to \$1,186 through July. Over 10,000 of the individuals filing initial claims, 6.4 percent of the total initial claims filed, indicated that they were previously employed in a management occupation.


Companies

One-third of the businesses located in Rhode Island had at least one worker file an initial claim against their company in the two month period between March 8 and May 9, 2020. The number of initial claims filed by company workers ranged from one initial claim filed by employees of more than 5,600 companies to over 900 initial claims filed by employees of three companies.

- Over 10,000; 40.9 percent of the state's small employers, those with less than twenty workers had at least one worker file an initial claim accounting for 38.4 percent of the group's total workforce.
- Over 2,800; 95 percent of the state's mid-size employers, those with 20 to 99 workers had at least one worker
 file an initial claim numbering 48,551 initial claims and accounting for 41 percent of the group's total
 workforce.
- All of the state's large employers, those with 100 to 499 workers had at least one worker file an initial claim numbering 34,556 initial claims, approximately one-third of the group's workforce.
- All of the state's largest employers, those with 500 or more workers had at least one worker file an initial claim numbering 21,463 initial claims, 21.2 percent of the group's total workforce.

Business establishments with just one Rhode Island location employ over 327,000 workers accounting for 76 percent of the state's private sector workforce. Overall, 49 percent of these single establishments employed workers who filed at least one initial claim during the period accounting for nearly 35 percent of the total jobs located at these establishments. The hardest hit community in terms of job loss was Tiverton where 135 (42.5%) businesses experienced over 1,300 temporary job losses accounting for over half the workforce of businesses 40,000 located only in Tiverton. Other hard hit communities included Cranston, North Providence, East Greenwich, Narragansett, Glocester and Newport, where over half the single establishments employed workers who filed initial claims accounting for over 40 percent of the jobs located at these establishments.

Demographics

The 162,700 initial claims filed by Rhode Island workers between March 8 and May 9, 2020 represented 34 percent of the total workers eligible for unemployment insurance benefits. Women accounted for 51.4 percent of the claims filed while men accounted for 47.3 percent. These percentages were on par with the shares Men (46.9%) and Women (53.2%) represent of the total covered employment.

Younger workers, those between the ages of 16 to 24, and 25 to 34 accounted for larger shares of initial claims filings than their shares of covered employment. Together these workers account for less than a third (32.9%) of the covered employment but represented over 42.4 percent of the initial claims filings.


In terms of race and ethnicity, white workers accounted for nearly 62 percent of the claims filed while representing 77 percent of the covered employed. Over one quarter of White, non-Hispanic workers filed initial claims while over one-third of both Black, non-Hispanic and Hispanic workers filed initial claims.

Individuals with high school diplomas accounted for over one-third of the initial claims filings, followed by those with some college or Associates Degrees (27.9%) or Bachelor's Degrees or higher (27.1%). Over half of the workers with high school degrees filed initial claims during the "Covid Crisis".

Reopening Rhode Island

In May, Rhode Island began the process of reopening the state's economy. Reopening occurred in Phases with the state moving from one phase to the next based on pre-established criteria which monitored the spread of the virus. Between April and November, the state has regained 64,400 jobs, nearly 60 percent of the jobs lost. But in December, a resurgence of Covid-19 cases lead to an economic "pause" which once again restricted activities for gyms, recreation facilities and restaurants resulting in a loss of 5,800 jobs.



The state ended the year with an unemployment rate of 7.9 percent, the tenth highest rate in the country. There were 495,900 Rhode Islanders residents employed in December 2020 and 42,800 unemployed, up 22,400 over the year. The state's labor force was down 23,600 from December 2019. The number of jobs in the state is still down 49,400 or 9.7 percent since February's all-time high of 507,200 with employment in the Leisure & Hospitality (-17,400), Education & Health Services (-11,900) and Professional & Business Services (-3,400) industries significantly below pre-pandemic levels.
