

Request Rhode Island Recognition of Out-of-State Apprentice Registration

Apprenticeship Sponsors registered with the US Office of Apprenticeship or another State Apprenticeship Agency may seek reciprocal approval from DLT so their apprentices may perform on-the-job learning hours in Rhode Island. This is essential to work in Rhode Island as an apprentice. Sponsors seeking reciprocal approval must meet Rhode Island wage and hour provisions and apprentice ratio standards.

DLT requires the following items submitted together to process your application. You may submit as one email including all attachments. Scanned copies of documents are acceptable. Incomplete submissions will be returned for you to complete.

1. EVIDENCE of CURRENT APPRENTICE REGISTRATION.

2. PHOTO ID. Driver's license or other valid government-issued photo identification.			

3. EVIDENCE THAT SPONSOR CAN MEET REQUIRED RATIO on the JOB in RHODE ISLAND

Attach **Company Ratio Sheet**. This lists employees with RI licenses, or for non-licensed trades a list of employees paid as journeyworkers in the trade, demonstrating the company meets RI ratio guidelines for the project where On-the-Job Learning will occur. https://dlt.ri.gov/forms/#apprenticeship - Look under "Sponsor Registration."

4. EVIDENCE THAT SPONSOR MEETS RHODE ISLAND WAGE REQUIREMENTS

Demonstrate journeyworker wage and apprentice wage comply with Rhode Island Labor Laws.

Reciprocal approval is valid for up to one year and can be renewed. There is no fee. The recognition is only valid while the individual remains registered as an apprentice. Apprentices in the licensed building trades will receive a Rhode Island Apprenticeship Card.
