

2023 RHODE ISLAND EMPLOYMENT & WAGE REPORT

Rhode Island's recovery from the COVID-19 pandemic continues.


Total employment in RI averaged 487,974 in 2023, an increase of 6,687 (1.4%) from the 2022 average of 481,287. Private Only employment rose to 427,057 from 420,915, a 1.5% increase.

The sectors that saw the highest growth percentage in employment were Utilities with 16 percent, Agriculture, Forestry, Fishing, & Hunting with 14.5 percent, and Arts, Entertainment, & Recreation with 9.9 percent. We saw a decrease in Management of Companies, & Enterprises of 15.1 percent.

Total wages paid by employers increased by 4.1 percent, resulting in a 2.7 percent increase in the average annual wage to \$66,217. Whereas Private Only wages paid by employers increased by 3.8 percent, bringing the average annual wage to \$64,435.

Annual average wages increased by 6.5 percent in Construction, 6.4 percent in Mining, 5.8 percent in Other Services. We also saw a decrease of 11.2 percent in Management of Companies & Enterprises.

QCEW is the Quarterly Census of Employment and Wages. The QCEW program data is developed through a cooperative agreement between the Rhode Island Department of Labor & Training and the US Bureau of Labor Statistics. The program derives its data from quarterly tax reports submitted by employers subject to Rhode Island's Unemployment Insurance law. Employment covered by these UI programs represents about 97% of all wage and salary civilian employment in the country.
