INDUSTRY OUTLOOK 2032

THE BIG PICTURE

Rhode Island employment in 2032 is projected to reach 564,230 an increase of nearly 33,000 (6.2%) from our 2022 employment. Some of this growth is attributed to the continued recovery from the nationwide pandemic that began in 2020.

Nationally, employment is projected to increase by 2.8 percent.

The largest increases on a percentage basis are seen in the Utilities sector (17.5%), followed by the Transportation & Warehousing (15.5%) and Arts, Entertainment, and Recreation (13.4%) sectors. Conversely, a few sectors, such as Mining, Quarrying, and Oil and Gas Extraction (-1.7%) and Finance and Insurance (-0.1%), are projected to experience slight declines. The data indicates a robust recovery and expansion in key industries, contributing to the overall economic growth of the state.

SNAPSHOTS OF SELECTED INDUSTRY SECTORS

HEALTH CARE & SOCIAL ASSISTANCE (NAICS 62)

The Health Care & Social Assistance sector is expected to add over 8,000 (+10.2%) jobs during the projection period. Growth is driven by increased demand for services, reflecting an aging population and advancements in medical technology. The subsectors of Ambulatory Health Care Services and Nursing and Residential Care Facilities, in particular, are expected to see notable increases in employment, highlighting the importance of these services in the overall health of RI citizens.

ACCOMMODATION & FOOD SERVICES (NAICS 72)

Above average growth (6.9%) in the Accommodation & Food Services sector will generate nearly 3,500 new jobs. This sector consists of two subsectors: Accommodation & Food Services & Drinking Places. Food Services & Drinking Places dominate this sector representing nearly 90 percent of the industry employment. The majority of new jobs (+2,075) is projected to be in Food Service & Drinking Places.

RETAIL TRADE (NAICS 44-45)

The Retail Trade industry is a major employer within the Rhode Island economy, showing both growth and stability. The employment in this sector is projected to grow from 47,256 in 2022 to 49,610 by 2032, resulting in a net gain of 2,354 positions, which corresponds to a growth rate of 5.0 percent. This increase indicates a healthy expansion of the sector, providing more employment opportunities over the projection period.

MANUFACTURING (NAICS 31-33)

The Manufacturing sector in Rhode Island is projected to experience mixed growth and decline across various sub-sectors from 2022 to 2032. Overall, the sector is expected to see a modest increase in total employment, growing from 40,172 jobs in 2022 to 41,120 jobs in 2032, which represents a 2.4% increase. Sub-sectors like Transportation Equipment Manufacturing and Food Manufacturing are expected to lead this growth with significant increases of 1,484 (24.7%) and 674 (16.5%), respectively. However, several traditional manufacturing industries, such as Textile Mills, Paper Manufacturing, and Printing and Related Support Activities, are expected to face declines. Despite these challenges, Rhode Island's manufacturing sector will continue to play a crucial role in the state's economy, driven by advancements and growth in specific highdemand sub-sectors.

PROFESSIONAL, SCIENTIFIC & TECHNICAL SERVICES (NAICS 54)

This sector is expected to add over 3,000 (+10.3%) jobs during the projections period reflecting an increased demand for specialized professional services across various fields like computer systems, engineering, legals services and consulting.
