
2018 RHODE ISLAND EMPLOYMENT & WAGE REPORT

In 2018, employment in Rhode Island averaged 481,683 with an average annual wage of \$53,726. Private sector employment averaged 421,477 with an average annual wage of \$51,747. Between 2017 and 2018 Rhode Island added 3,515 private sector jobs and the average annual private sector wage increased \$817, a 1.6% increase.

The Health Care & Social Assistance sector employed 19% of the entire private sector workforce. Wages in the sector rose an average of \$999 or 2.1% compared to 2017.

The three cities with the largest share of private employment for 2018 in Rhode Island were Providence 98,348, Warwick 44,654 and Cranston 31,466. These cities hold over 41% of the employment in the private sector. The cities where the average annual wage was the highest for 2017 were Smithfield \$77,340, West Greenwich \$75,158 and Narragansett \$62,527. Tiverton showed the largest percentage gain in employment compared to 2017 with a 13.4% increase in private sector employment followed by Central Falls (5.3%) and Jamestown (4.3%). The largest percentage gains in private establishments were in Central Falls (7.5%), Scituate (3.9%) and Barrington (3.2%).
