

# 2020 RHODE ISLAND EMPLOYMENT & WAGE REPORT

#### Rhode Island's annual average wage increased at a record high in 2020.

While total employment in RI decreased by an average of 8.4 percent in 2020, total wages paid by employers increased by nearly one percent resulting in a ten percent increase in the average annual wage, marking the largest year over year increase in at least 50 years.


Total employment averaged 444,633 in 2020, a decrease of 40,871 (-8.4%) from the 2019 average of 485,504. Wages paid by public and private sector establishments totaled nearly \$26.9 billion an increase of over \$220 million (0.8%) from the 2019 total wages paid.

Employment in the state's private sector declined by an average of 39,238 primarily due to the pandemic related shutdown which started in the second quarter of 2020, resulting in a 9.2 percent decrease over the year. Job losses occurred in nearly all sectors of the economy with the Accommodation & Food Services sector accounting for nearly one-third of the over-the-year decline.

The pandemic disportionatley hurt lower wage jobs driving the annual average wages up at unprecedented levels. Annual average wages increased by more than 8 percent in nearly all sectors and municipalities.

QCEW is the Quarterly Census of Employment and Wages. The QCEW program data is developed through a cooperative agreement between the Rhode Island Department of Labor & Training and the US Bureau of Labor Statistics. The program derives its data from quarterly tax reports submitted by employers subject to Rhode Island's Unemployment Insurance law. Employment covered by these UI programs represents about 97% of all wage and salary civilian employment in the country.
