Weekly Update of Claims Activity

Week Ending: April 18, 2020

Unemployment Insurance

Initial Claims – 17,930 initial claims were filed during the week ending 4/18/20, a decrease of 4,379 from the previous week, and an increase of 14,357 from a year ago. Of the 17,930 initial claims filed, 17,027 were due to COVID-19. Through April 17th, there have been a total of 128,575 COVID-19 initial claims filed. This week there were 19,456 Pandemic Unemployment Assistance (PUA) initial claims processed.

Continued Claims – 78,259 continued claims were processed during the week of 4/18/20, an increase of 7,897 from the previous week and an increase of 70,391 from a year ago. This week there were 2,109 continued claims processed for Pandemic Unemployment Insurance (PUA).

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 63 initial claims and 583 continued claims were processed. An estimated 18 layoffs were prevented this week as a result of Workshare.

Exhaustions – 222 individuals exhausted their regular payments this week, an increase of 27 from the previous week and an increase of 41 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 1,698 initial claims and 9,765 continued claims were filed for Temporary Disability Insurance. Of the 1,698 initial claims filed, 936 were due to COVID-19. The average weekly TDI payment is \$494 per week. Rhode Island is currently paying an average of 8.3 weeks per new claim. To date there have been 26,947 TDI claims and 10,569 COVID-19 claims filed.

Temporary Caregiver Insurance – Of the 1,698 TDI initial claims, 302 (17.8%) were TCI Claims. This week 860 TCI payments were issued totaling \$389,667. The average weekly TCI payment was \$453. Of the 26,947 TDI claims filed in 2020, 6,667 or 24.7% were TCI claims. This week a total of 123 COVID-19 related TCI claims were filed.
