

Rhode Island Department of Labor and Training Weekly Update of Claims Activity

Week Ending: March 7, 2020

Unemployment Insurance

Initial Claims – 685 initial claims were processed during the week ending 3/7/20, a decrease of 137 from the previous week, and a decrease of 54 from a year ago. The number of initial claims filed to date is down 10.0 percent from last year and down 8.7 percent from two years ago.

Continued Claims - 10,854 continued claims were processed during the week of 3/7/20, a decrease of 1,318 from the previous week and a decrease of 736 from a year ago. The number of continued claims filed to date is down 4.9 percent from last year and down 8.1 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 30 initial claims and 459 continued claims were processed. An estimated 8 layoffs were prevented this week as a result of Workshare.

Exhaustions – 128 individuals exhausted their regular payments this week, an increase of 16 from the previous week and a decrease of 4 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 876 initial claims and 7,709 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$535 per week. Rhode Island is currently paying an average of 10.3 weeks per new claim. To date there have been 9,294 TDI claims filed.

Temporary Caregiver Insurance – Of the 876 TDI initial claims, 265 (30.3%) were TCI Claims. This week 521 TCI payments were issued totaling \$285,577. The average weekly TCI payment was \$548. Of the 9,294 TDI claims filed in 2020, 2,602 or 28.0% were TCI claims.
