

Rhode Island Department of Labor and Training Weekly Update of Claims Activity

Week Ending: December 28, 2019

Unemployment Insurance

Initial Claims – 3,642 initial claims were processed during the week ending 12/28/19, an increase of 1,940 from the previous week, and an increase of 98 from a year ago. The number of initial claims filed to date is down 1.2 percent from last year and down 5.6 percent from two years ago.

Continued Claims - 8,177 continued claims were processed during the week of 12/28/19, an increase of 537 from the previous week and a decrease of 60 from a year ago. The number of continued claims filed to date is down 3.0 percent from last year and down 8.9 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 8 initial claims and 135 continued claims were processed. An estimated 2 layoffs were prevented this week as a result of Workshare.

Exhaustions – 130 individuals exhausted their regular payments this week, no change from the previous week and an increase of 7 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 564 initial claims and 6,955 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$534 per week. Rhode Island is currently paying an average of 10.2 weeks per new claim. To date there have been 49,009 TDI files claimed

Temporary Caregiver Insurance – Of the 564 TDI initial claims, 201 (35.6%) were TCI Claims. This week 359 TCI payments were issued totaling \$213,183. The average weekly TCI payment was \$594. Of the 49,009 TDI claims filed in 2019, 12,855 or 26.2% were TCI claims.
