

Rhode Island Department of Labor and Training Weekly Update of Claims Activity

Week Ending: December 14, 2019

Unemployment Insurance

- **Initial Claims** 1,321 initial claims were processed during the week ending 12/14/19, a decrease of 186 from the previous week, and an increase of 35 from a year ago. The number of initial claims filed to date is down 1.3 percent from last year and down 5.4 percent from two years ago.
- **Continued Claims** 7,102 continued claims were processed during the week of 12/14/19, an increase of 588 from the previous week and a decrease of 261 from a year ago. The number of continued claims filed to date is down 3.1 percent from last year and down 9.0 percent from two years ago.
- **Workshare** gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 4 initial claims and 123 continued claims were processed. An estimated 1 layoff was prevented this week as a result of Workshare.
- **Exhaustions** 148 individuals exhausted their regular payments this week, an increase of 38 from the previous week and a decrease of 8 from a year ago.

Temporary Disability Insurance

- **Temporary Disability Insurance** 942 initial claims and 7,745 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$524 per week. Rhode Island is currently paying an average of 10.2 weeks per new claim. To date there have been 47,528 TDI files claimed
- **Temporary Caregiver Insurance** Of the 942 TDI initial claims, 224 (23.8%) were TCI Claims. This week 450 TCI payments were issued totaling \$270,148. The average weekly TCI payment was \$600. Of the 47,528 TDI claims filed in 2019, 12,416 or 26.1% were TCI claims.
