

Rhode Island Department of Labor and Training Weekly Update of Claims Activity

Week Ending: August 17, 2019

Unemployment Insurance

- **Initial Claims** 865 initial claims were processed during the week ending 8/17/19, an increase of 142 from the previous week, and an increase of 54 from a year ago. The number of initial claims filed to date is down 0.1 percent from last year and down 3.9 percent from two years ago.
- **Continued Claims** 8,134 continued claims were processed during the week of 8/17/19, a decrease of 141 from the previous week and a decrease of 610 from a year ago. The number of continued claims filed to date is down 1.9 percent from last year and down 8.3 percent from two years ago.
- **Workshare** gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 8 initial claims and 471 continued claims were processed. An estimated 3 layoffs were prevented this week as a result of Workshare.
- **Exhaustions** 135 individuals exhausted their regular payments this week, an increase of 20 from the previous week and an increase of 3 from a year ago.

Temporary Disability Insurance

- **Temporary Disability Insurance** 920 initial claims and 6,755 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$537 per week. Rhode Island is currently paying an average of 10.2 weeks per new claim. To date there have been 31,397 TDI files claimed
- **Temporary Caregiver Insurance** Of the 920 TDI initial claims, 257 (27.9%) were TCI Claims. This week 521 TCI payments were issued totaling \$302,195. The average weekly TCI payment was \$580. Of the 31,397 TDI claims filed in 2019, 7,931 or 25.3% were TCI claims.
