

Rhode Island Department of Labor and Training Weekly Update of Claims Activity

Week Ending: July 13, 2019

Unemployment Insurance

Initial Claims – 820 initial claims were processed during the week ending 7/13/19, a decrease of 524 from the previous week, and a decrease of 274 from a year ago. The number of initial claims filed to date is up 2.0 percent from last year and down 3.4 percent from two years ago.

Continued Claims - 9,279 continued claims were processed during the week of 7/13/19, an increase of 882 from the previous week and a decrease of 177 from a year ago. The number of continued claims filed to date is down 1.5 percent from last year and down 8.3 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 97 initial claims and 140 continued claims were processed. An estimated 21 layoffs were prevented this week as a result of Workshare.

Exhaustions – 148 individuals exhausted their regular payments this week, an increase of 5 from the previous week and a decrease of 6 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 995 initial claims and 7,407 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$518 per week. Rhode Island is currently paying an average of 10.1 weeks per new claim. To date there have been 26,507 TDI files claimed

Temporary Caregiver Insurance – Of the 995 TDI initial claims, 263 (26.4%) were TCI Claims. This week 476 TCI payments were issued totaling \$255,239. The average weekly TCI payment was \$536. Of the 26,507 TDI claims filed in 2019, 6,548 or 24.7% were TCI claims.
