Weekly Update of Claims Activity

Week Ending: June 15, 2019

Unemployment Insurance

Initial Claims – 1,125 initial claims were processed during the week ending 6/15/19, an increase of 398 from the previous week, and an increase of 263 from a year ago. The number of initial claims filed to date is up 4.6 percent from last year and down 1.3 percent from two years ago.

Continued Claims -6,226 continued claims were processed during the week of 6/15/19, a decrease of 118 from the previous week and a decrease of 98 from a year ago. The number of continued claims filed to date is down 1.9 percent from last year and down 8.4 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 70 initial claims and 231 continued claims were processed. An estimated 14 layoffs were prevented this week as a result of Workshare.

Exhaustions – 147 individuals exhausted their regular payments this week, a decrease of 22 from the previous week and an increase of 6 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 942 initial claims and 7,004 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$511 per week. Rhode Island is currently paying an average of 10.2 weeks per new claim. To date there have been 22,600 TDI files claimed

Temporary Caregiver Insurance – Of the 942 TDI initial claims, 227 (24.1%) were TCI Claims. This week 421 TCI payments were issued totaling \$253,761. The average weekly TCI payment was \$603. Of the 22,600 TDI claims filed in 2019, 5,584 or 24.7% were TCI claims.
