Weekly Update of Claims Activity

Week Ending: June 8, 2019

Unemployment Insurance

Initial Claims – 727 initial claims were processed during the week ending 6/8/19, an increase of 258 from the previous week, and an increase of 58 from a year ago. The number of initial claims filed to date is up 3.7 percent from last year and down 2.3 percent from two years ago.

- **Continued Claims** 6,344 continued claims were processed during the week of 6/8/19, a decrease of 34 from the previous week and a decrease of 28 from a year ago. The number of continued claims filed to date is down 1.9 percent from last year and down 8.3 percent from two years ago.
- **Workshare** gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 51 initial claims and 756 continued claims were processed. An estimated 12 layoffs were prevented this week as a result of Workshare.

Exhaustions – 169 individuals exhausted their regular payments this week, an increase of 32 from the previous week and an increase of 29 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 999 initial claims and 7,277 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$508 per week. Rhode Island is currently paying an average of 10.2 weeks per new claim. To date there have been 21,658 TDI files claimed

Temporary Caregiver Insurance – Of the 999 TDI initial claims, 247 (24.7%) were TCI Claims. This week 431 TCI payments were issued totaling \$244,984. The average weekly TCI payment was \$568. Of the 21,658 TDI claims filed in 2019, 5,357 or 24.7% were TCI claims.
