Weekly Update of Claims Activity

Week Ending: June 1, 2019

Unemployment Insurance

Initial Claims – 469 initial claims were processed during the week ending 6/1/19, a decrease of 186 from the previous week, and a decrease of 97 from a year ago. The number of initial claims filed to date is up 3.6 percent from last year and down 2.3 percent from two years ago.

- **Continued Claims** 6,378 continued claims were processed during the week of 6/1/19, a decrease of 348 from the previous week and a decrease of 128 from a year ago. The number of continued claims filed to date is down 1.9 percent from last year and down 8.2 percent from two years ago.
- **Workshare** gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 13 initial claims and 368 continued claims were processed. An estimated 3 layoffs were prevented this week as a result of Workshare.

Exhaustions – 137 individuals exhausted their regular payments this week, a decrease of 30 from the previous week and a decrease of 8 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 858 initial claims and 6,521 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$517 per week. Rhode Island is currently paying an average of 10.2 weeks per new claim. To date there have been 20,659 TDI files claimed

Temporary Caregiver Insurance – Of the 858 TDI initial claims, 194 (22.6%) were TCI Claims. This week 373 TCI payments were issued totaling \$210,632. The average weekly TCI payment was \$565. Of the 20,659 TDI claims filed in 2019, 5,110 or 24.7% were TCI claims.
