Weekly Update of Claims Activity

Week Ending: May 18, 2019

Unemployment Insurance

Initial Claims – 683 initial claims were processed during the week ending 5/18/19, a decrease of 8 from the previous week, and a decrease of 144 from a year ago. The number of initial claims filed to date is up 4.0 percent from last year and down 0.2 percent from two years ago.

Continued Claims -6,587 continued claims were processed during the week of 5/18/19, a decrease of 174 from the previous week and an increase of 40 from a year ago. The number of continued claims filed to date is down 2.0 percent from last year and down 8.0 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 84 initial claims and 446 continued claims were processed. An estimated 19 layoffs were prevented this week as a result of Workshare.

Exhaustions – 146 individuals exhausted their regular payments this week, a decrease of 11 from the previous week and a decrease of 3 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 970 initial claims and 6,906 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$524 per week. Rhode Island is currently paying an average of 10.1 weeks per new claim. To date there have been 18,895 TDI files claimed

Temporary Caregiver Insurance – Of the 970 TDI initial claims, 227 (23.4%) were TCI Claims. This week 460 TCI payments were issued totaling \$271,595. The average weekly TCI payment was \$590. Of the 18,895 TDI claims filed in 2019, 4,673 or 24.7% were TCI claims.
