Weekly Update of Claims Activity

Week Ending: May 4, 2019

Unemployment Insurance

Initial Claims – 617 initial claims were processed during the week ending 5/4/19, a decrease of 489 from the previous week, and a decrease of 65 from a year ago. The number of initial claims filed to date is up 5.1 percent from last year and up 0.5 percent from two years ago.

- **Continued Claims** -7,209 continued claims were processed during the week of 5/4/19, a decrease of 2,352 from the previous week and a decrease of 15 from a year ago. The number of continued claims filed to date is down 2.2 percent from last year and down 7.8 percent from two years ago.
- **Workshare** gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 17 initial claims and 468 continued claims were processed. An estimated 4 layoffs were prevented this week as a result of Workshare.

Exhaustions – 140 individuals exhausted their regular payments this week, a decrease of 27 from the previous week and a decrease of 44 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 862 initial claims and 7,516 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$510 per week. Rhode Island is currently paying an average of 10.2 weeks per new claim. To date there have been 17,023 TDI files claimed

Temporary Caregiver Insurance – Of the 862 TDI initial claims, 222 (25.8%) were TCI Claims. This week 515 TCI payments were issued totaling \$280,250. The average weekly TCI payment was \$544. Of the 17,023 TDI claims filed in 2019, 4,241 or 24.9% were TCI claims.
