Weekly Update of Claims Activity

Week Ending: April 13, 2019

Unemployment Insurance

Initial Claims – 741 initial claims were processed during the week ending 4/13/19, an increase of 83 from the previous week, and a decrease of 167 from a year ago. The number of initial claims filed to date is down 1.6 percent from last year and down 7.5 percent from two years ago.

Continued Claims – 8,653 continued claims were processed during the week of 4/13/19, a decrease of 1,230 from the previous week and a decrease of 427 from a year ago. The number of continued claims filed to date is down 2.3 percent from last year and down 7.4 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 28 initial claims and 383 continued claims were processed. An estimated 6 layoffs were prevented this week as a result of Workshare.

Exhaustions – 152 individuals exhausted their regular payments this week, a decrease of 27 from the previous week and a decrease of 33 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 965 initial claims and 7,378 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$508 per week. Rhode Island is currently paying an average of 10.1 weeks per new claim. To date there have been 14,314 TDI files claimed

Temporary Caregiver Insurance – Of the 965 TDI initial claims, 237 (24.6%) were TCI Claims. This week 431 TCI payments were issued totaling \$235,386. The average weekly TCI payment was \$546. Of the 14,314 TDI claims filed in 2019, 3,513 or 24.5% were TCI claims.
