Weekly Update of Claims Activity

Week Ending: March 16, 2019

Unemployment Insurance

Initial Claims – 885 initial claims were processed during the week ending 3/16/19, an increase of 146 from the previous week, and an increase of 71 from a year ago. The number of initial claims filed to date is up 1.9 percent from last year and down 3.3 percent from two years ago.

- **Continued Claims** 11,523 continued claims were processed during the week of 3/16/19, a decrease of 67 from the previous week and an increase of 374 from a year ago. The number of continued claims filed to date is down 2.8 percent from last year and down 6.9 percent from two years ago.
- **Workshare** gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 2 initial claims and 548 continued claims were processed.

Temporary Disability Insurance

Temporary Disability Insurance – 1,036 initial claims and 7,797 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$510 per week. Rhode Island is currently paying an average of 10.2 weeks per new claim. To date there have been 10,481 TDI files claimed

Temporary Caregiver Insurance – Of the 1,036 TDI initial claims, 234 (22.6%) were TCI Claims. This week 477 TCI payments were issued totaling \$252,284. The average weekly TCI payment was \$529. Of the 10,481 TDI claims filed in 2019, 2,553 or 24.4% were TCI claims.
