## Weekly Update of Claims Activity

Week Ending: March 2, 2019

## **Unemployment Insurance**

**Initial Claims** – 790 initial claims were processed during the week ending 3/2/19, a decrease of 1,089 from the previous week, and a decrease of 52 from a year ago. The number of initial claims filed to date is up 1.4 percent from last year and down 1.8 percent from two years ago.

**Continued Claims** – 12,899 continued claims were processed during the week of 3/2/19, an increase of 1,115 from the previous week and a decrease of 245 from a year ago. The number of continued claims filed to date is down 3.7 percent from last year and down 7.0 percent from two years ago.

**Workshare** – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 1 initial claim and 270 continued claims were processed.

**Exhaustions** – 132 individuals exhausted their regular payments this week, an increase of 7 from the previous week and a decrease of 9 from a year ago.

## Temporary Disability Insurance

**Temporary Disability Insurance** – 906 initial claims and 7,408 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$521 per week. Rhode Island is currently paying an average of 10.1 weeks per new claim. To date there have been 8,509 TDI files claimed

**Temporary Caregiver Insurance** – Of the 906 TDI initial claims, 274 (30.2%) were TCI Claims. This week 434 TCI payments were issued totaling \$250,582. The average weekly TCI payment was \$577. Of the 8,509 TDI claims filed in 2019, 2,133 or 25.1% were TCI claims.
