## Weekly Update of Claims Activity

Week Ending: February 23, 2019

## **Unemployment Insurance**

**Initial Claims** – 1,879 initial claims were processed during the week ending 2/23/19, an increase of 858 from the previous week, and a decrease of 40 from a year ago. The number of initial claims filed to date is up 2.0 percent from last year and down 1.4 percent from two years ago.

**Continued Claims** – 11,784 continued claims were processed during the week of 2/23/19, a decrease of 76 from the previous week and a decrease of 256 from a year ago. The number of continued claims filed to date is down 3.9 percent from last year and down 6.8 percent from two years ago.

**Workshare** – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 0 initial claims and 91 continued claims were processed.

**Exhaustions** – 125 individuals exhausted their regular payments this week, a decrease of 11 from the previous week and an increase of 7 from a year ago.

## Temporary Disability Insurance

**Temporary Disability Insurance** – 832 initial claims and 6,726 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$520 per week. Rhode Island is currently paying an average of 10.2 weeks per new claim. To date there have been 7,603 TDI files claimed

**Temporary Caregiver Insurance** – Of the 832 TDI initial claims, 192 (23.1%) were TCI Claims. This week 417 TCI payments were issued totaling \$228,362. The average weekly TCI payment was \$548. Of the 7,603 TDI claims filed in 2019, 1,859 or 24.5% were TCI claims.
