Weekly Update of Claims Activity

Week Ending: February 16, 2019

Unemployment Insurance

Initial Claims – 1,021 initial claims were processed during the week ending 2/16/19, an increase of 136 from the previous week, and an increase of 30 from a year ago. The number of initial claims filed to date is up 2.8 percent from last year and up 1.1 percent from two years ago.

Continued Claims – 11,860 continued claims were processed during the week of 2/16/19, a decrease of 5 from the previous week and a decrease of 396 from a year ago. The number of continued claims filed to date is down 4.2 percent from last year and down 6.5 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 0 initial claims and 337 continued claims were processed.

Exhaustions – 136 individuals exhausted their regular payments this week no change from the previous week and an increase of 10 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 1,008 initial claims and 7,307 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$512 per week. Rhode Island is currently paying an average of 10.2 weeks per new claim. To date there have been 6,771 TDI files claimed

Temporary Caregiver Insurance – Of the 1,008 TDI initial claims, 227 (22.5%) were TCI Claims. This week 500 TCI payments were issued totaling \$279,447. The average weekly TCI payment was \$559. Of the 6,771 TDI claims filed in 2019, 1,667 or 24.6% were TCI claims.
