Weekly Update of Claims Activity

Week Ending: February 2, 2019

Unemployment Insurance

Initial Claims – 1,441 initial claims were processed during the week ending 2/2/19, an increase of 54 from the previous week, and an increase of 278 from a year ago. The number of initial claims filed to date is up 3.1 percent from last year and up 4.2 percent from two years ago.

Continued Claims - 11,999 continued claims were processed during the week of 2/2/19, an increase of 713 from the previous week and a decrease of 442 from a year ago. The number of continued claims filed to date is down 4.6 percent from last year and down 6.4 percent from two years ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 5 initial claims and 375 continued claims were processed. An estimated 3 layoffs were prevented this week, as a result of Workshare.

Exhaustions – 112 individuals exhausted their regular payments this week a decrease of 3 from the previous week and an increase of 15 from a year ago.

Temporary Disability Insurance

Temporary Disability Insurance – 862 initial claims and 7,491 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$508 per week. Rhode Island is currently paying an average of 10.2 weeks per new claim. To date there have been 4,793 TDI files claimed

Temporary Caregiver Insurance – Of the 862 TDI initial claims, 253 (29.4%) were TCI Claims. This week 511 TCI payments were issued totaling \$275,124. The average weekly TCI payment was \$538. Of the 4,793 TDI claims filed in 2019, 1,245 or 26.0% were TCI claims.
