## Weekly Update of Claims Activity

Week Ending: January 19, 2019

## **Unemployment Insurance**

**Initial Claims** – 1,472 initial claims were processed during the week ending 1/19/19, a decrease of 195 from the previous week, and a decrease of 197 from a year ago.

**Continued Claims** – 11,664 continued claims were processed during the week of 1/19/19, an increase of 172 from the previous week and an increase of 261 from a year ago.

Workshare – gives employers an alternative to layoffs by allowing employees to work reduced hours and collect a percentage of regular UI benefits to compensate for lost pay. This week, 41 initial claims and 428 continued claims were processed. An estimated 21 layoffs were prevented this week, as a result of Workshare.

**Exhaustions** – 138 individuals exhausted their regular payments this week a decrease of 28 from the previous week and a decrease of 13 from a year ago.

## Temporary Disability Insurance

**Temporary Disability Insurance** – 884 initial claims and 7,459 continued claims were processed for Temporary Disability Insurance. The average weekly TDI payment is \$510 per week. Rhode Island is currently paying an average of 10.2 weeks per new claim. To date there have been 2,753 TDI files claimed

**Temporary Caregiver Insurance** – Of the 884 TDI initial claims, 275 (31.1%) were TCI Claims. This week 561 TCI payments were issued totaling \$320,985. The average weekly TCI payment was \$572. Of the 2,753 TDI claims filed in 2019, 749 or 27.2% were TCI claims.
