Monthly Update

Month Ending: March 31, 2019

Unemployment Insurance

Initial Claims -3,167 initial claims were processed during the month of March, a decrease of 1,534 (-32.6%) from the previous month, and a decrease of 312 (-9.0%) from a year ago. Of the 2,135 monetary determinations issued in March 138 (6.5%) were monetarily ineligible.

Weeks Claimed – 46,449 weeks claimed were processed during the month of March, a decrease of 2,941 (-6.0%) from the previous month and an increase of 315 (0.7%) from a year ago. There were 44,592 payments made in March, which resulted in payments totaling \$16.6 million. There were 2,297 (5.2%) partial payments issued in March 2019 compared to 2,452 (5.6%) last year. The average weekly benefit payment was \$373. The number of weekly benefit payments is averaging 14.8 weeks per claim.

Workshare – 80 initial claims were processed for Workshare benefits this month, an increase of 71 (788.9%) from the previous month and a decrease of 44 (-35.5%) from March 2018. It is estimated that 20 layoffs were averted this month as a result of Rhode Island's Workshare program.

First and Final Claims – 1,926 first payments and 601 final payments were issued in March 2019. The current exhaustion duration ratio is 27.0 percent.

Non-monetary Determinations -1,384 non-monetary determinations were issued during the month of March 2019. Of the 1,384 determinations, 847 (61.2%) were separation issues and 537 (38.8%) were non-separation issues. Denials were issued for 329 (38.8%) separation issues and 526 (98.0%) non-separation issues.

Appeals – 284 appeal decisions were processed with the Board of Review in March 2019. Of the 284 processed, 221 (77.8%) were filed by UI applicants and 63 (22.2%) were filed by employers. The Board upheld the director's decision in nearly two-thirds of the cases.
