## Monthly Update

Month Ending: January 31, 2019

## **Unemployment Insurance**

**Initial Claims** – 7,020 initial claims were processed during the month of January, a decrease of 2,048 (-22.6%) from the previous month, and a decrease of 729 (-9.4%) from a year ago. Of the 5,683 monetary determinations issued in January 202 (3.6%) were monetarily ineligible.

Weeks Claimed – 49,482 weeks claimed were processed during the month of January, an increase of 9,644 (24.2%) from the previous month and a decrease of 11,843 (-19.3%) from a year ago. There were 44,493 payments made in January, which resulted in payments totaling \$16.2 million. There were 2,356 (5.3%) partial payments issued in January 2019 compared to 3,151 (5.9%) last year. The average weekly benefit payment was \$363. The number of weekly benefit payments is averaging 15.0 weeks per claim.

**Workshare** – 67 initial claims were processed for Workshare benefits this month, an increase of 10 (17.5%) from the previous month and a decrease of 33 (-33.0%) from January 2018. It is estimated that 29 layoffs were averted this month as a result of Rhode Island's Workshare program.

**First and Final Claims** – 5,029 first payments and 600 final payments were issued in January 2019. The current exhaustion duration ratio is 27.2 percent.

Non-monetary Determinations – 1,498 non-monetary determinations were issued during the month of January 2019. Of the 1,498 determinations, 898 (59.9%) were separation issues and 600 (40.1%) were non-separation issues. Denials were issued for 370 (41.2%) separation issues and 551 (91.8%) non-separation issues.

**Appeals** – 358 appeal decisions were processed with the Board of Review in January 2019. Of the 358 processed, 285 (79.6%) were filed by UI applicants and 73 (20.4%) were filed by employers. The Board upheld the director's decision in nearly two-thirds of the cases.
